The National Institute of Animal Biotechnology (NIAB), is an autonomous institute established by Department of Biotechnology, Ministry of Science & Technology, Govt. of India at Hyderabad. NIAB is aimed to harness novel and emerging biotechnologies and create knowledge in the cutting edge areas for improving animal health and productivity. The Institute's research focus is on animal genetics and genomics, transgenic technology, reproductive technology, diseases, nutritional enrichment, and bioinformatics. The Institute aims at translational research leading to genetic enhancement of Indian Livestock species and basic research towards development of novel vaccines, diagnostics and improved therapeutic molecules for farm animals. Applications / Nominations are invited from Indian Nationals including non-resident Indians (NRIs) for the post of 'Director', National Institute of Animal Biotechnology (NIAB), Hyderabad. **The position offers a unique opportunity to those willing to take up a challenging assignment** and provide dynamic leadership in scientific, academic and administrative matters relating to the institute. The candidate is expected to establish NIAB as a world class research institute and guide multi-disciplinary research teams.

1. Eligibility Criteria

Scientists from Central/State Governments, research institutes, autonomous bodies, Government funded Research organizations / Institutes etc

- (i) holding analogous post on regular basis in the parent cadre / Department or
- (ii) with 5 years' service in the post with Pay Matrix Level-14 (Rs. 1,44,200 2,18,200) or equivalent in the parent cadre / Department and possessing the qualifications & experience as below.

2. Job Specifications

- (i) To provide academic and administrative leadership to the institute.
- (ii) The post carries a basic pay of Rs. 2,25,000/-(Level-17 as per 7th CPC) with allowances as per Central Government Rules for appointment on Deputation (ISTC)/Absorption.
- (iii) The period of deputation includes period of deputation in other ex-cadre posts, held immediately preceding this appointment in the same or other organization / Department should ordinarily not exceed 5 years. The maximum age limit for appointment on deputation (ISTC) should not exceed 58 years as on the closing date of receipt of applications.

- (i) A Ph.D. degree in Veterinary Sciences/ Animal Sciences/ Modern Biology/ Life Sciences/ Dairy Sciences or equivalent with specialization in the relevant area.
- A minimum of 15 years of research experience in responsible positions in the area of Veterinary Sciences/ Animal Sciences or any discipline relevant to Animal /Veterinary Sciences.
- (iii) Excellent track record in the form of quality publications, evidence of patents and Technologies developed/Transfer.
- (iv) Professional eminence in the form of fellowships of national / international academics, national / international awards etc.

Desirable:

- (i) Proven ability to interact with national and international organizations.
- (ii) Understanding of various overarching aspects of Animal Science / Veterinary Science or any discipline relevant for Animal/Veterinary Sciences.
